Aerator Jet nozzles are water level dependent fountain nozzles. They are constructed out of cast bronze, machined brass and copper.



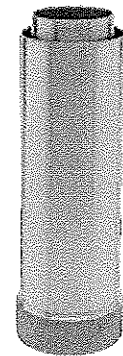
